

## BOARD OF TRUSTEES

Since its inception in 1973, CORR The Jute Works was registered as a Women's Non-profit Marketing Trust with the first Board of Trustees comprised of members of the Management Committee. The present Board of Trustees consists of nine members, of whom the Chairperson is nominated by Caritas Bangladesh. The Director of CJW is involved in the BoT as an ex-officio member, there are two Lifetime Trustees (the founders). Five representatives of different artisan groups, elected by the artisans, and at the end of their term they are eligible for reelection for another term. Thus, the Board of Trustees is ensuring the participation of women and artisans in the management and decision making of the organization. The Current BoT consists of:

After completion of a three-year term, the representatives of the artisan groups retire in the reporting year. The last election was organized on July, 2015 for the term of 2015-18.




The Board of Trustees formed an Election Commission consisting Ananda P. Gomes, Milton S. Ratna and Anita M. Rozario, to conduct the election of the Board members. The commission successfully conducted the election in three regions (Chandpur, Jagaroni and the self-running groups at CDI) on 23 July and 31 July. In Chandpur, 17 representatives from 18 groups elected Uttara Rani Chowdhury of Shahatoli group. In Jagaroni, 29 representatives from 38 groups elected Shimul Cruze of Vurulia and 42 representatives from 43 Self-running groups elected Nilu Mondal of Razabazar group and Rita Gonsalves of Provati group as the board members for next three years (2015-18)

## OPERATIONAL PROCESS

The design section of CJW develops new designs based on the market trend and taste. Then the samples are sent both by physical and digital ways to the buyers abroad to receive their market feedback. From these samples, the buyers select their products and place their order to CJW. The production section disburses the orders among the relevant artisans. Raw materials are provided from CJW and often the artisans also buy those from local sources. The production process mostly takes place in the homes of individual artisans. In six centers (Jagaroni, Chandpur, Jalchatra, Provati, Noakhali and Mirerbazar) artisans work together under the supervision of the centers. Artisans perform the quality checking at their group level and centre level; finally they bring the crafts to the Quality Control Section of CJW. After passing through the quality checking, these crafts are handed over to the store and packing sections for export packing to ready them for shipment to the buyers. The shipping section prepares relevant documents in two phases: pre-shipment documents for having customs formalities at the origin. Then the final documents for the buyers concerning clearing of a consignment on arrival at its destination.

There are thirteen sections in CJW, of which eight are directly involved in production and marketing of the products, two are involved in Fair Trade and development activities and the other three are for support service. The chart below shows the steps in the operation process and marketing of the crafts.

#### National Export Trophy won by CORR - The Jute Works

The Honorable Prime Minister of the Peoples Republic of Bangladesh, Sheikh Hasina handed over the National Export Trophy and certificates for 2011-12 and 2012-13 among the export organizations for their significant role in overseas trade and thus earning foreign currency. The awards were distributed at a program organized jointly by the Ministry of Commerce and the Export Promotion Bureau (EPB) at Osmani Memorial Auditorium on 28 August 2016.

CJW has achieved Silver Trophy for both years under the Handicraft category. In the absence of the Director(her family tour to USA), on behalf of CJW: Sebastian Rozario, Assistant Executive Director (Finance & Admin) of Caritas Bangladesh (former Deputy Director of CJW) and Ananda P. Gomes, Deputy Director of CJW received the Trophies.

Presided over by Commerce Minister Tofail Ahmed, Chairman of the Parliamentary Standing Committee on Commerce Ministry Md Tajul Islam Chowdhury, Senior Secretary of the Commerce Ministry Hedayetullah Al Mamun, FBCCI President Abdul Matlub Ahmad and EPB Vice Chairman Mafruha Sultana spoke at the function.

In her speech, Prime Minister urged businesspeople to explore new export destinations and product diversification to reduce over dependence on garments and a few markets. The Prime Minister also recommended the businessmen set up more labour intensive industrial units so that more young people can be employed in those factories. "We'll provide all support," she said, assuring also facilities necessary to boost trade and commerce, industrialization and investment.

#### **Guarantee System Audit of WFTO**

CJW achieved the World Fair Trade Organization's Guarantee Certificate after successfully completion of the guarantee audit. Mr. Ram Bhat, the GS consultant of WFTO has audited the CJW on 25 January to 2 February. The auditor visited 14 cooperative groups, 5 production centres and 9 supplier groups on the audit purpose. In the audit, CJW was found comply with all the 10 principles of Fair Trade with a very few minor improvements. WFTO provided the Guarantee certificate with extended four years validity, generally the validity is for two years.

On January 07, CORR-The Jute Works (CJW), started its export activity for the year 2016 through the 'Fair Trade Thanksgiving and Packing Opening Ceremony'. The Life Trustee Rev. Father Richard W. Timm CSC was present as the Chief Guest and Sister Mary Lillian SMRA was present as the special Guest. The Chairperson of CJW Board of Trustees, Dr. Benedict Alo D'Rozario presided over the ceremony.

The guests were welcomed by the Director Bertha Gity Baroi. In her speech she presented the CJW's performance during last year. She shared on the Ten principles of Fair Trade and thanked all stakeholders for their contribution. She presented the plans of 2016.

Sr. Lillian thanked the all for another fruitful year. She highlighted the benefits received by the rural artisans through Fair Trade. She also mentioned the surplus sharing with the artisans. In the Chief Guest's speech, Fr. R.W Timm conveyed his thanks to the Fair Trade. He shared some anecdotes of the early days of CJW.

In the Chairperson's speech, Dr. D' Rozario greeted all on the Christmas and New Year. He spoke on the message of Christmas: We should thank and praise the Creator for His blessings and we have to share the gift that He has given. He shared on the three approaches: "Charity approach, Professional approach & MBM approach. He advised to all to balance the approaches during our work.

The speech session was followed by the Packing inauguration. The guests came forward and put the products of 1st shipment in the export carton. At the end there was a small but interesting cultural presentation followed by lunch.

#### **Ambiente Fair 2016**

On 12-16 February Ananda Placid Gomes and Vashkor D' Costa from CJW participated in Ambiente Fair at Frankfurt, Germany. CBI (Foreign Trade development organ of Netherlands Government) supported CJW to attend the fair under its HDHT program. On 13 February, WFTO launched its Product Label in the Fair ground. Some products of CJW were also displayed in the WFTO common place arranged for the FTO members. CJW received queries from 49 buyers. 10 Regular Buyer like Gepa, CTM, Traidcraft, One village, Mansion Bengal, Caritas Germany visited and discussed on next order on the displayed samples. During the reporting period about seven orders received of an amount of US\$ 118,000. Caritas Germany gave an assurance in the fair for a big order and in the end of April, CJW received an order for US\$ 84,000.

#### **World Fair Trade Day 2016**

CORR-the Jute Works (CJW) celebrated the World Fair Trade Day 2016 on 14 May 2016 having the theme 'Fair Trade and Planet'. The Director Bertha Gity Baroi shared on the Ten principles of Fair Trade. Development manager Milton Suranjit Ratna spoke on the theme of WFTDay. He urged all to 'Save the mother nature by promoting Justice to the Nature and human'.

On this occasion, CJW handed-over the 'National Craft Council Young Artisan Competition' prize money of Tk. 25,000 to Akhi Pereira of Razabazar Samity. CJW also arranged a human chain.

In the afternoon CJW participated the program organized by ECOTA Fair Trade Forum at 'Jatra Biroti'. The program contained of seminar, human chain, folk music and Fair Trade Fair. CJW Director spoke on the seminar. The CJW cultural team has preformed on the 10 principles of Fair Trade. Nine FTOs participated for the whole day long Fair Trade Fair. The CJW family provided support for organizing the event.

#### Young Crafts person Award

Bangladesh National Crafts Council arranged a young artisan (not over 30) award to encourage all the young artisans all over Bangladesh. Four young artisans participated in the competition on behalf of CJW. On December 5, at their 29th Annual General Meeting, National Craft Council of Bangladesh handed over the award to Akhi Pereira, artisan of CJW's Razabazar samity. Akhi was awarded for the decorative Christmas Ball she made by Jute and handmade papers.

#### Fair Trade audit of Jatra & Classic Handmade

Requested by WFTO Asia, the Director, Manager- Development & information and Ecota's program manager visited the two craft organizations: Jatra and Classical Handmade. During the visit they have audited the organization on their activities regarding the ten principles of Fair Trade. Based on their recommendation, both the organizations have achieved the Ecota's membership.

#### Capacity Building at the Centres

On 15-17 September, Development & Information section organized a Follow-up tailoring program at the Jalchatra center of Tangail district. Sixteen artisans from the previous workshop participated in the follow-up training. In the training they have learned to make several kinds of ladies dresses. Through the training they are now able to execute the local orders and Caritas silk orders.

On 13-15 December, CJW organized braided jute craft training at Baniarchar, Koligram groups of Gopalgonj district. Those two groups had fewer orders during last year. About twenty artisans were trained on Jute doll key-ring, several kinds of mats, baskets. The feedback of the training was tremendous. These two groups have executed the bulk Key-ring order given by Caritas Germany.

#### Capacity building at Dhakua

On 31 August to 3 September, CJW arranged capacity building workshop at Dhakua parish of Tarakanda Upazila, Mymensingh. Based on the feasibility study of the Development section, it was planned to train the Garo women of three villages on Hand-made paper, Wheat-straw and Shola based Greetings card making. About 31 trainees received the training from three experts on the product range. Father Simon Hacha Parish Priest of St. Peter Church inaugurated and Milton S Ratna Manager, Development & Information coordinated the workshop. The participants were happy and confident to produce the cards which have a potential market within the country and abroad. In the mean time they ware able to sell more than 500 cards to Germany. Fr. #### Feasibility study

Upon request of the Parish Priest of Golla of Nowabgonj Upazilla under Dhaka district, Fr. Subrata Bonifas Gomes and the Deotola Youth Association, a feasibility study was arranged on 28 September on the possibility to start a cooperative group in Deotola with the local women. The Development manager visited the houses of the women and find out that majority of the women are from solvent families and are involved with crafts made by plastic beads not as profession but use of idol time. As there is no scope to start any crafts from local raw materials at present, CJW offered the group to help them to connect with the local boutique

cantas Chittagong region also requested to CJW for measuring possibility of the indigenous hand loomed cloths and Shaal produced by the ICDP beneficiaries of Ruma, Thanchi and Roangchori Upazila of Bandarban and Rajasthali Upazila of Rangamati. CJW arranged for feasibility study on these areas to explore the possibility of the fabrics in November 2015. Milton S. Ratna and Niranjan Mondal carried out the study. Feedback in the local market was positive. Based on the finding, two local orders of Shaal were already executed.

CJW received a request from the BSRM Foundation to check the possibility to work with the women of the border area those are vulnerable to human trafficking. A team containing the Director, Development manager, Production manager and Designer visited the Durgapur centre under Sarsha upazila (close to Benapole border) of BSRM foundation on 30-31 March. The women are trained in Jessore sewing and tailoring. CJW collected samples from them for market study.

The rally was led by the State Minister for Women and children affairs, Meher Afroze Chumki, MP.

#### **National Girl Child Day**

CJW observed the National Girl Child Day on 12 October, 2015. The staffs and artisans of CJW participated in the rally and discussion meeting with Caritas, Girl child advocacy forum and other organizations. The Director Bertha Gity Baroi lit the candle for Saint Josephine Bakhita. The Development manager Milton Suranjit Ratna interpreted the prayer card and shared. After the prayer, documentary made by Caritas Lebanon along with some other documentary on South Asian situation made by United Nations and International Presses were shown. The documentaries touched the heart of all participants. The Director shared with the participants on the ten things about trafficking.

In the open session, it was pointed out that CJW can do more in this issue. Many of the women who were trafficked to India and rescued are sent back to Bangladesh, to prevent them to fall in the same trap, CJW can train them on craft making and provide them work in the centres. The meeting concluded with the Director's willingness to work for the traffic victims.

#### CJW's activity on the Climate change

"Climate change affects everyone, but especially the poor and most vulnerable people among us- Inspired by Pope Francis and the Laudato Si' encyclical, CJW participated in the petition campaign organized by the Global Catholic Climate Movement. CJW also applied for two slots of Prayer campaign and arranged the prayer for the UN Climate summit in Paris COP21 on 29 and 30 November. In the prayer, the Development manger has shared from the Papal writing on climate and videos on climate effect also arranged.

On 28 November CJW jointly participated with Caritas Bangladesh in the Global Climate March with the theme 'For the Safe and Clean Bangladesh', organized by the national committee for Climate March. The march started from Central Shaheed Minar. covered Supreme Court, Suhrawardy Uddan and ended at Shahbag National Museum.

The campaign is proven success as the World leaders agreed to cut carbon emissions to keep the global temperature rise below the dangerous 1.5°C threshold, and to aid the world's poorest in coping with climate change impacts on December 12, 2015.

## Ruma Akhter and her mission for a better life

Ruma Akhter (32) and her husband: Md Monir Hossain lives in a rented house in Purbomonipur of Mirpur with their family consisting of one son and one daughter. The boy is 8 and studies in class one while the girl is 5 and will be admitted in the school. Ruma's husband is a small trader.

Ruma's mother was involved in the handicraft group and through that income supported the educational expenses of Ruma and her two brothers. Ruma was the second among the siblings. She got married after completion of school graduation. Monir was working as a cable TV connector. So, for the solvency of the family Ruma completed a nursing training and joined a private clinic. Within one year, her son was born. To look after the son, Ruma had to quit the job. She was searching for an alternative job. She learnt the craft making skill from her mother during her maiden stage. So, with that familiarity, she applied to Purbomonipur Hastashilpa Samity of CORR - The Jute Works. She was taken in the group as a member.

From the handicraft making Ruma earned about four to five thousand taka per month. She started save some money. In the meantime, Monir had to quit the job due to some problem. Ruma took a loan of Taka 10,000 from the group for her husband to start vegetable vending. With the income from both husband and wife, they met the expenses of the family and saved money for future. After paying back the loan, Ruma took a second loan of Taka 15,000 to expand the vegetable shop. Now they are able to earn about Taka 20,000 per month and able to provide nutritious food, better education to the children.

Ruma seats in the shop everyday for two hours (2 to 4 in the afternoon) beside her craft production. Even she continues her work while looking after the shop. Ruma is very competent with the new and complex designed crafts.

At present her savings in the group is about Taka 21,723. Ruma is now earning more than her nursing job and as well as able to take care of her children. Her dream is higher education for her children. Ruma is day-by-day improving her situation and for this she is grateful to CORR - The Jute Works.







#### We also report that:

- a) we have obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purposes of our audit and made due verification thereof;
- b) in our opinion, proper books of account as required by law have been kept by the organization so far as it appeared from our examination of those books;

## TEN PRINCIPLES OF FAIR TRADE

#### Principle One: Creating Opportunities for Economically Disadvantaged Producers

Poverty reduction through trade forms a key part of the organization's aims. The organization supports marginalized small artisans, seeks to enable them to move from income insecurity and poverty to economic self-sufficiency and ownership.

#### Principle Two: Transparency and Accountability

The organization is transparent in its management and commercial relations. It is accountable to all its stakeholders and respects the sensitivity and confidentiality of information. The organization involves employees and artisans in decision-making processes.

#### **Principle Three: Fair Trading Practices**

The organization trades with concern for the social, economic and environmental well-being of marginalized artisans and does not maximize profit at their expense. It is responsible and professional in meeting its commitments in a timely manner. Fair Trade recognizes, promotes and protects the cultural identity and traditional skills of small artisans.

#### Principle Four: Payment of a Fair Price

Fair price is mutually agreed by all through dialogue and participation, which provides fair pay to the artisans and can also be sustained by the market. Fair pay means provision of socially acceptable remuneration considered by artisans themselves to be fair and equal pay for equal work by women and men.

#### Principle Five: Ensuring no Child Labor and Forced Labor

The organization adheres to the UN Convention on the Rights of the Child, and national / local law on the employment of children. The organization ensures that there is no forced labor in its workforce.

## Principle Six: Commitment to Non Discrimination, Gender Equity and Women's Economic Empowerment and Freedom of Association

The organization does not discriminate based on race, caste, national origin, religion, disability, gender, sexual orientation, union membership, political affiliation, HIV/Aids status or age. The organization has a clear Gender policy that ensures that women as well as men have the ability to gain access to the resources that they need to be productive and also the ability to influence the wider policy, regulatory, and institutional environment that shapes their livelihoods and lives. The organization respects the right of all employees and to bargain collectively.

#### **Principle Seven: Ensuring Good Working Conditions**

The organization provides a safe and healthy working environment for employees, working hours and conditions for employees/members comply with national and local laws and ILO conventions. Fair Trade Organizations seek to raise awareness of health and safety issues and improve health and safety practices in artisan groups.

#### **Principle Eight: Providing Capacity Building**

The organization develops the skills and capabilities of its own employees/members. Organizations working directly with small artisans to help these artisans to improve their management skills, production capabilities and access to markets – local / international / Fair Trade and mainstream as appropriate.

#### Principle Nine: Promoting Fair Trade

The organization raises awareness of the aim of Fair Trade and of the need for greater justice in world trade through Fair Trade. It advocates for the objectives and activities of Fair Trade according to the scope of the organization.

#### **Principle Ten: Respect for the Environment**

Organizations maximize the use of raw materials from sustainably managed sources, buying locally when possible. They use production technologies that seek to reduce energy consumption and where possible use renewable energy. They seek to minimize the impact of waste stream on the environment. All organizations use recycled or easily biodegradable materials for packing to the extent possible.
