Message from the Director



We are excited to publish the Annual Report for the FY 2022-23 which contains a vivid image of the trade and development activities of our journey with Love, Nature, and Trade Justice.

For some years CJW had to look for other crafts than Jute for survival because of the decreasing demand for jute goods. But now the market is gaining shifts. The diversified jute craft industry has been reviving its previous glory which is influenced by the awareness of climate change issues and the use of eco-friendly products.

Despite numerous challenges in this fiscal year, CJW gained a remarkable volume of exports to 17 countries amounting to USD 1.7 million. The major challenge CJW faced in the reporting year was unfair competition in the market. Another challenge was the worldwide economic crisis. It was very much challenging for CJW to keep the growth of trade.

The CJW Board analyzed the economic recession and price hike and decided to increase the wages of the Artisans living in urban areas by 25%. This will have a negative impact on the annual turnover but still the well-being of the artisans was given utmost priority as a Fair Trade Organization.

Socially marginalized communities were always the priority of CJW activities. This year new artisans groups were formed with the Adivasi (Indigenous) people in the northern districts. This will give us a scope to uplift their socio-economic condition and break the poverty tangle.

The Effluent Treatment Plant (ETP) for processing wastewater has been made operational during this year. This will ensure the proper management of wastewater and reduce the risk of contamination of water. We thank everyone who financially supported and worked for it.

It is my pleasure to announce that the Golden Jubilee celebration of CJW was started in this reporting period and a grand event was organized afterward in September 2023. On this joyous occasion, I extend my sincere greetings to all concerned including its staff, thousands of artisans, buying partners, and well-wishers. I am grateful to those who made the long journey of CJW possible and brought the successes.

We are very much thankful to our buying partners and well-wishers who buy, support and promote our Fair Trade crafts in the international markets. Through buying crafts from CJW you are helping thousands of rural Artisans who are fighting against poverty and trying to live with dignity. It would not have been possible for us to serve our women Artisans without your contribution and continued support.

I also thank the team who prepared this annual report and made it presentable. The whole CJW team performed well this year and helped to achieve the target for driving forward.

We appreciate your kind support in the coming days to work with you hand in hand to make the world Fairer and wish you all the best regards.

Development and Capacity Building

Installation of the Mural of Caritas Patron

Operation of Effluent Treatment Plant (ETP)

CJW started the operation of Effluent Treatment Plant (ETP) in June 2023 which is the very first ETP in the handicrafts industry in Bangladesh. It is a specialized facility designed to treat and purify industrial wastewater before its safe discharge into the environment.



Distribution of Warm Cloths

CJW Distributed blankets to 100 Adivasi (Indigenous) families in Baligram village under Upazila of Dinaipur. This support was given with the joint financial contribution of Staff and CJW. The Director-CJW Mr. Shishir Anjelo Rozario, Regional Director Caritas Dinaipur Mr. Ranion John Paul Rozario, Parish Priest of Mariampur Parish Rev. Fr. Silas Murmu and the Village Leaders distributed the blankets. The villagers were happy to receive the gift from CJW.



Human Trafficking - Awareness Program



As a Trust of Caritas Bangladesh, aiming the global awareness against human trafficking February 08, 2023, CORR-The Jute Works (CJW) observed the International Prayer and Awareness Day with its all staff. A Development Training was organized on 17-19 March, 2023 on key-ring making. A new group was formed for poor Adibasi (Indigenous) women of Boligram in Kalai Upazila under Joypurhat district. A total of 30 trainees participated in the training.



MoU Signed with Sight Savers

A MoU was signed between Sightsavers (Royal Commonwealth Society for the Blind) and CORR - The Jute Works (CJW) on 24/05/2023 for the Eye-health care of the Artisans. The Country Director of Sightsavers Ms. Amrita Rejina Rozario and The Director of CJW Mr. Shishir Anjelo Rozario signed the MoU on behalf of the organizations. Since the inception of CJW, it has been working as a registered Fair-Trade Trust since September 2, 1973 producing & marketing handicrafts for the socio-economic development of marginalized women as it was established. Sightsavers is a non-profit making non-government organization, incorporated in the United Kingdom as a charity with its principal.



CORR-The Jute Works organized a Inclusive Eye Care Programme 2023 30.05.2023 at Borodal Samity, Sharkhira, Khulna. The service was given by Dhaka Shiromoni Eye Hospita, Khulna. The Parish Priest of Shatkhira Church Rev. Father Philip Mondol, Rev, Father Songkor Mondol attend the program. Mr. Shishir Anjelo Rozario, Director-CJW and Sr. mazry protiva SMRA were also present in the program. A total of 120 producers and their families from Shatkhira area got different eye treatments through this event.

The service was given by Dhaka Progressive Lions Eye Hospital, Norshindi, with the financial support from Sightsavers (Royal Commonwealth Society for the Blind). The Parish Priest of St. Nicholas Church Rev. Father Khokon V. Gomes attend the program as a Chief Guest. Ms. Amrita Rejina Rozario, Country Director-Sightsavers, Mr. Rafiqul Islam, Program Director-Sightsavers and Mr. Shishir Anjelo Rozario, Director-CJW were also present in the program. A total of 230 producers and their families from Nagori area got different eye treatments through this event.

WFTO Audit

He shared about the environmental issue and our role to protect our mother earth. Mango Saplings were distributed to 31 producers. After the program, CJW Director and other Staff members planted 200 Mango saplings at CJW Vadun center.



Ekmattra Entrepreneurs Ltd. Signed a MoU with CORR - The Jute Works (CJW)

Since the inception of CJW in 1973, it has been working for the socio-economic development of marginalized women as it was established. Ekmattra is also working for financial self-reliance and empowerment of deprived women. Considering the similar nature of activities and goals/objectives, both the party joined hands and mutually agreed to work together for strengthening good works and sustainable development of the country. The Director of CJW Mr. Shishir Anjelo Rozario and the Chairman of



Ekmattra Entrepreneurs Ltd. Mr. Shubhashish Roy was present at the MoU signing program. The period of the MoU is for two years.

Sarala Gomes is an orphan girl. She lost her father when she was a child, even she cannot remember her father. She can remember only her mother. She has no other siblings. She was the sole survivor of her widowed mother. After her father died, her mother used to work in other people's houses to support their family. Within few years, her mother sent her to Panjora Boarding School. From there she got education, and learnt various activities with the Sisters. When Sarala Gomes was 17 years old she got married to a man named Rafael Gomes from Karan village in Nagori. Her husband's family was very poor, while her husband was unemployed. Her mother-in-law made her do

a lot of work inside and outside the house and also tortured her physically and mentally. She used to work in other people's houses and often she passed whole days without food. The sisters offered her husband a job at Caritas. After her husband got a job at Caritas, their luck of family began to change.

Sarala Gomes has three sons and one daughter. At the beginning of CJW, Sister Michael Francis and Sister Mary Lilian SMRA went to the Koran village to train up the women in make jute products. Thus Sarala started a new chapter of her life with the touch of Golden Fiber. She used jute to make various designs of mats, carpets, bags, baskets, boats, etc. and earned money by selling them through the CORR-The Jute Works office. She bore all the expenses of his son and daughter's education. She was able to build a new house in place of his house.

Later Sister Mary Pratibha SMRA went to the village and formed an active group. Sarala Gomes was elected as leader of that Artisans' group. She collected the goods of woman Artisans and sent them to the Sisters in Jagarani Center. She was very good at making new jute products and the samples of her new products were sent to the CORR-The Jute Works.

She worked in CORR-The Jute Works for nearly 45 years through Jagarani. She is now 80 years old. Although she is not able to work as she used to due to being old enough but she is still engaged in the manufacture of some jute products in her mind. Her desire is to be involved in this work till the end of her life and encourage others to become self-reliant. She is grateful to CORR-The Jute Works forever.

Artisan's Story Anta Rani's Dream Come True

Anta Rani an Artisan from "Kot Bari Mahila Samiti" has been working with CORR-The Jute Works since 1985.

She was born in a very poor family. She got involved in jute work through her mother and sister. They had no support other than their father's ancestral home. After the marriage of her elder sister, she took the reins of the family by making jute craft with her mother and took the responsibilities of her younger brothers and sisters on her shoulders. Further disaster befell the family when her father died. She and her mother made living by making jute products. She made her brothers and sisters educated.



Later her mother married her off to a goldsmith boy. After marriage, she thought it was time to be happy in her life, maybe she would not have to face any more hardships. But she was no longer happy. Because her husband's income was not that good, it became very difficult for them to run their household on his husband's income alone. Therefore, Anta Rani has to rejoin the work of making jute products. She started making jute products with confidence and boldness. She used her income to support her husband and their family and 3 children.

As she herself could not get the scope of higher education, her dream was to educate her children in higher education. She mentioned that CORR-The Jute Works showed a light of hope in his dark life of poverty.

Today she is a successful mother because she has been able to fulfill that dream. Today her elder son is a software engineer, elder daughter is doing her post-graduation in microbiology and younger daughter is studying in 9th standard.

Now she is an idol and inspiration for other Artisans. She is grateful to the "Samity" to stand and support her during the struggling time of her life. She wants to serve the "Samity" as long as she is workable.

She wished the prosperity and success of CORR-The Jute Works.
